Terms and Conditions

- These fees only apply to fast track cases where fixed costs apply to cases for acccident occurring and exiting the RTA/EL/PL/OL
 portal on or after 31 July 2013 for RTA, EL, PL and OL cases. Disease cases are not included.
- 2. A minimum fee of £150 plus vat will apply in all cases.
- 3. Trial fees are still recoverable as a separate disbursement from the Defendant, and will be charged in accordance with CPR recoverable rates.
- 4. If a case is allocated to the multi track or exits fixed recoverable costs, then Counsel's standard hourly rate will apply to any further work undertaken on the case.
- 5. Conditional Fee Agreements are available on fixed recoverable costs cases, subject to a review of prospects of success. Work may be undertaken in accordance with the table of fees provided if Counsel is prepared to enter into a Conditional fee agreement.
- 6. Instructing Solicitors need only provide papers necessary for Counsel to undertake the work such i.e. medical report, proof of evidence, pleadings and necessary supporting documents.
- 7. Pleadings and advices will be returned by email within 14 days.
- 8. Infant advice cases will be provided for £150 for non-portal cases and £150 for portal cases (limited to one medical report).
- 9. Fee for applications will be charged in accordance with fixed costs in the CPR.
- 10. Counsel's fixed costs shall become payable from the Solicitor's costs at the conclusion of the case.
